Manulife Financial, through its i-Watch program, which includes the investments under the Certified Diversified Warranty, monitors the quantitative and qualitative performance of the investment managers and the investments. Manulife Financial declares the following investment managers are wholly owned subsidiaries: Manulife Asset Management Limited and Manulife Asset Management Limited (US) LLC operating as Portfolio Solutions Group (PSG).
- 3. GRS has substantially provided the recordkeeping, tax reporting and other administrative services stipulated in the Plan Services Agreements or Service and Fee Agreement (as applicable) according to applicable legislation. We confirm that our services have been developed and delivered to meet or exceed the applicable standards of the CAP Guidelines.
- 4. GRS produced a Section 5970 Report on Controls Placed in Operation and Tests of the Operating Effectiveness of Controls (CICA Section 5970) covering the period from January 1, 2011 to September 30, 2011 together with a Bridge letter providing assurance that the controls continue operate effectively for the period of October 1, 2011 to December 31, 2011. This report offers the results of a comprehensive audit completed by the independent, external auditing firm of Ernst & Young LLP, and concentrates on our key internal controls. The Auditor's Report is dated December 8, 2011 and the Bridge letter is dated January 5, 2012.
- 5. The assets of the pension fund held by Manulife Financial are held under an insurance policy issued to the plan sponsor solely for the purpose of funding the plan and has been registered, where applicable, with the appropriate regulators, and indicates that the investment is held for the plan.
- Manulife Financial has an employee Code of Business Conduct, Records Management and Privacy Policies to which all
 employees must adhere.
