

Want to get a jump on doing your taxes, but haven't received your RRSP tax receipts? Or maybe you can't find a tax receipt.

Did you know that you can get a copy of your RRSP tax receipts (for any RRSP contributions you've made) and slips (for any RRSP withdrawals) in your member secure site? It's quick, easy and secure.

Once you're in the site, you can confirm and, if necessary, update your mailing address, which is important, since your tax receipts and slips will be mailed to you during tax season.

And you will see a summary of the RRSP contribution tax receipts and withdrawal tax slips (T4RSPs) issued to you in the last three years. You can view, download and print any of the receipts or slips shown.
