

Submitting contribution payments

We offer several ways to submit contribution payments. Here are the different options:

1. Electronic Fund Transfer (EFT)
2. Internet banking
3. Wire transfer

1. Electronic Fund Transfer (EFT)

What is an Electronic Fund Transfer?

It is a transfer of funds processed through our secure website at your request, from your account to ours.

How does it work?

You set up your bank account information under the Administration tab of the VIP Room for plan sponsors. The bank account will appear as a selection in the Method drop down menu when submitting your contribution list on our website. You then select the account you wish to pay the contributions from and confirm the payment.

2. Internet banking

What do I need to know

You can remit contributions and pay invoices electronically for your Manulife Group Savings & Retirement plans (GSR) through your financial institution's Internet and telephone service.

How does it work?

- Add **MANULIFE-GRS-WITH RS NO** as a payee.
- Indicate your **account number** (RS _____) and transfer your contribution/payment amount.
- Include the **confirmation number** with your contribution file before sending it to your Customer Service Representative (CSR).

3. Wire transfer

What is a wire transfer?

Wire transfers, transfers of money from one bank account to another, are arranged through your bank in order to submit your payment to Manulife's Bank of Montreal account.
