Operating expenses at December 31, 2016

The following table provides a summary of the operating expenses of the i-Watch funds at December 31, 2016.

Our fee illustrations and quotations detail our investment management fees, which are composed of a base investment management fee in addition to fund specific surcharges and discounts. These fees are deducted from gross unit values on a plan specific basis. In addition to these investment management fees, fund operating expenses are sometimes charged, either by Manulife and/or the third party fund manager directly to the funds. The operating expenses may include, but are not limited to, accounting and valuation costs, audit and legal fees, applicable taxes, regulatory filing fees, custodial and safekeeping charges, trustee fees, and the costs of preparing and distributing annual and semi-annual reports, prospectuses, statements and investor communications. Fund operating expenses may be applied at the group segregated fund level and at the underlying fund level. At its discretion, Manulife may sometimes absorb the fund operating expenses relating to the group segregated fund if, for example, the size of the fund is too small in relation to the expenses.

With respect to disclosing these fund operating expenses, Manulife takes a very open approach to disclosing all fund related expenses. First, Manulife group segregated fund expenses and the underlying third-party fund expenses are separately disclosed to members and plan sponsors on our fund summary sheets, which are updated quarterly and published on the member and plan sponsor online sites for easy access. In addition, all fund operating expenses charged to the funds are reflected in the gross unit values as well as the gross rates of return disclosed.
